THE MINUTES

August 30, 2010

The Holmes County Commissioners met in regular session Monday, August 30, 2010; with everyone present. Chairman Miller opened the meeting:

BOB SIGLER – DEPUTY CLERK/FINANCE – POSTAGE EQUIPMENT DISCUSSION

Deputy Clerk/Finance Bob Sigler and Ed Britt of the Landfill/Recycling met with the Commissioners and discuss the postage meter located in the Treasurer's Office and the Recycling Contract with Republic.

First, Britt discussed the recycling bill we have been receiving from Republic Waste. The bill has almost doubled from what the original bill was supposed to according to the original Recycling Contract. The Commissioners will have Britt get a hold of Republic Waste and discuss the bill with them and eventually have Republic Waste meet with the Commissioners.

Next, Sigler discussed the supplies that were purchased for the Pitney Bowes postage machine located in the Treasurer's Office. The Treasurer's Office purchased supplies from a company other than Pitney Bowes and when the machine broke down, Pitney Bowers stated that the off brand supplies purchased for the machine were the cause of the break down. The Treasurer's Office would need to get a letter from Pitney Bowes stating that these companies' supplies were the reason for the breakdown of the postage machine and send it to the company that supplied the supplies and they would give a refund. Pitney Bowes refused to write a letter to this company and the Treasurer's Office does not know what to do with the supplies that they can no longer use. The Commissioners informed Sigler to have the Treasurer's Office contact other companies with postage machines and see if it is any cheaper to go with any of these companies.

BOARD OF ELECTIONS – APPROPRIATIONS DISCUSSION

Georgie Cool, Bonnie Self and Lisa Welch of the Board of Elections met with the Commissioners to discuss the money that they received from the Library if they could appropriate some of that money back into their salary line-item to get them through the rest of the year. The Commissioners informed the Board of Elections to go ahead with the Supplemental and put the money back into their salary line-item.

Next, the Board of Elections discussed their copy machine that will be going off the Gordon Flesch Contract in 2011. Ault informed them that he is currently speaking with someone that will come in and fix these machines that will no longer be covered under the contract.

Finally, discussed was the settlement that was reached with Diebold, the makers of their voting equipment. They have been given three options to choose from in this settlement and it has been recommended that they discuss this with the County Prosecutor also. The Commissioners informed them to go ahead and make their own decision with their Board concerning the settlement.
