ARLENE RADDEN - HOLMES COUNTY LIBRARY - DISCUSSION

Arlene Radden of the Holmes County Library, Steve Shrock, Becky Baker and Mrs. Davis of the Library Board met with the Holmes County Commissioners and announced a fund raising campaign to support the Book Mobile Program at the Holmes County Library. Shrock gave the background of the Book Mobile for Holmes County. So far, they have raised \$182,000.00. Radden informed the Commissioners that the Book Mobile goes to 65 to 70 Parochial Schools in Holmes County. Eyler asked for the expenditures of the Book Mobile last year. Radden informed him that they were between \$180,000.00 and \$200,000.00. The Library Board and Radden thanked the Commissioners for their time and the opportunity to speak with them today.
